Waiting Time at job sites is subject to a charge of \$ 100.00 per hour.

Returns are subject to a 10 % Restocking Charge for Stock Items, 30% for Non-Stock Items.

For retail pricing, we suggest that you add 25 % to 30 % to your cost. We quote non-contractors 25 % over your contractor price.

Terms for Approved Credit Customers- Net 30 Days, 2 % Interest after 30 Days.

Terms for other Customers- C.O.D. (Cash, Check, Money Order, VISA, MasterCard, American Express, Discover)

When a homeowner or job site owner (other than the contractor or builder) supplies a payment for COD, we will write that bill at the **RETAIL PRICE**, not your contractor's price. If you wish to extend your contractors discount to your customer, please do so after we have billed you. We hope that this will eliminate some confusion on COD invoices.
